e-transport Romania - Extension of the obligations to obtain UIT codes

Dear business partners and customers,

Today we are informing you about the introduction of the Romanian e-Transport system and the associated obligation (for the Romanian importer or exporter) to obtain a so-called UIT number for certain goods transports to and from Romania.

According to Government Emergency Ordinance (RNV) No. 115/2023, significant changes will be introduced, including to the "RO e-Transport" system, which will come into force on **01.07.2024** as things stand.

With the publication of RNV no. 115/2023, the scope of the RO e-Transport system has been extended, so that in the future, regardless of the type of goods, the obligation to declare the international road transport of goods will apply. As a result, the marking of shipments and the creation of unique transport codes (UIT) in the RO e-Transport system now applies both to the road transport of goods with a high tax risk within the Romanian territory and to the international road transport of any goods. This as long as the existing exemption limits of 10,000 RON (~2,000 €), or 500 kg per shipment are exceeded.

Recipients of goods in Romania must apply for a UIT code as part of the e-Transport procedure when importing the goods and send it to the shipper immediately upon loading.

The code must be presented by the driver in the event of an inspection in Romania. In order to generate a UIT code, users must enter the transport data in the RO e-Transport system no later than **three calendar days before the date indicated as the start of the transport**, but in any case at the border crossing when entering Romania or at the place of import or when the vehicle is actually put into service.

The UIT code is valid for five calendar days, in the case of intra-Community acquisitions for 15 calendar days, starting from the date specified at the start of transportation. It is prohibited to use the UIT code once it has expired.



To obtain the UIT code, the applying importer must also enter M&M Militzer & Münch Germany as the forwarding agent, border crossing point, truck/trailer license plate, customs tariff code, description, quantity, net weight, gross weight and value.

As the procedures for shipments to private individuals with regard to obtaining the UIT code are currently still unclear, any B2C shipments (subject to UIT) for Romania must be excluded from 01.07.2024 for the time being. We will inform you separately of any further news in this regard.

Non-compliance can result in high penalties (up to €20,000.00), so please coordinate the procedure with the specialist departments and inform your employees accordingly.

Should there be corresponding penalties / additional costs, we reserve the right to charge these further.

In general, the most important point remains that the Romanian customer/consignee/shipper has the obligation to obtain this code for affected shipments and to communicate it to you in good time if necessary.
